



Failure to have the Mare examined, and to notify Laura Cronk Equine Management, shall automatically render the live foal guarantee and any applicable rebreeding rights of CUSTOMER null and void.

CUSTOMER hereby agrees to keep Mare in good physical condition throughout the pregnancy, including vaccination against Rhinopneumonitis at the 5<sup>th</sup>, 7<sup>th</sup> and 9<sup>th</sup> months of pregnancy.

In the event Mare does not produce a live foal, the veterinarian certificate must include the following: (1) That Mare was properly vaccinated against Rhinopneumonitis and (2) that in the veterinarian's best judgment, the Mare was maintained in a reasonable state of health.

CUSTOMER understands that at least 24 hours advance notice must be provided to Laura Cronk Equine Management for semen collection and shipment (note that this means up to 48 hours prior to the time that customer actually receives the semen). If less than 24 hours advance notice is given, the request will be accommodated if reasonable possible, but at the sole discretion of Laura Cronk Equine Management. Normal semen collection will be done on WEEKDAYS on a first come first serve basis. Saturdays will be special arrangement only. NO SEMEN WILL BE COLLECTED OR SHIPPED ON SUNDAYS. Saturday semen collection must be shipped by same day courier. ALL COLLECTIONS WILL BE MADE ONLY BETWEEN THE HOURS OF 7 a.m. and 5 p.m. CUSTOMER assumes all responsibility for the condition of the Mare. In addition, Laura Cronk Equine Management shall not be responsible for any delays or failure in semen delivery.

In the event the mare fails to produce a live foal, the CUSTOMER is entitled to only re-breed the Mare in the first succeeding breeding season. In the event the mare fails to produce a live foal on rebreeding, CUSTOMER will not be entitled to another rebreeding or refund of any fees.

LAURA CRONK EQUINE MANAGEMENT in its sole discretion, may require that CUSTOMER provide a substitute mare as a condition for used or any rebreeding right. All breeding and rebreeding rights granted hereunder may not be sold, assigned, or otherwise transferred without prior written consent of LAURA CRONK EQUINE MANAGEMENT.

CUSTOMER agrees to pay all fees and cost of collection and transporting the semen directly to Laura Cronk.
